**RELEASE AND WAIVER OF LIABILITY
& INDEMNITY AGREEMENT**

Name of PARTICIPANT: _____

There are risks and dangers associated with participation in sports activities such as CRICKET, including but not limited to those of bodily injury, partial and or total disability, paralysis and death, from which the social and economic losses or damages could be severe. Those risks and dangers may be caused by the negligence of the participant or the negligence of others. There may also be other risks not currently known or not reasonably foreseeable.

Therefore, IN CONSIDERATION of the PARTICIPANT named above being permitted to participate in any activities of The Marin Cricket Club (hereinafter "The CLUB") including, but not limited to, participation in and observation of matches and/or practices, and any other use of club facilities or equipment, THE PARTICIPANT, and any personal representatives, heirs, and next of kin thereof, hereby agrees to the following:

1. THE PARTICIPANT HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE TO PARTICIPANT, whether caused by the negligence of the released parties or otherwise, while PARTICIPANT is participating in the activities, or using the facilities or equipment, of The CLUB.
2. THE PARTICIPANT HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE The CLUB, its directors, officers, employees, and agents (hereinafter referred to as the "RELEASED PARTIES") from all liability, for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting death of PARTICIPANT, whether caused by the negligence of the released parties or otherwise, while PARTICIPANT is participating in the activities, or using the facilities or equipment, of The CLUB.
3. THE PARTICIPANT HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS the RELEASED PARTIES and each of them from any loss, liability, damage or cost they may incur due to the participation of PARTICIPANT in the activities of The CLUB or use by PARTICIPANT of the facilities or equipment of The CLUB, whether caused by the negligence of the released parties or otherwise.
4. THE PARTICIPANT HEREBY AGREES THAT IT IS THEIR SOLE RESPONSIBILITY TO HAVE ADEQUATE HEALTH AND PERSONAL INJURY INSURANCE to cover any expenses in the event of an injury while participating in the activities of The CLUB.

This AGREEMENT is governed by California law and is intended to be as broad and inclusive as permitted thereby; further, if any portion of this AGREEMENT is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE, and further agrees that no oral representations, statements or inducements have been made.
